ENTRANCE WORK PERMIT

CONDITIONS AND RESTRICTIONS

1. All work performed under this permit shall be constructed in accordance with the Town of Chatham Highway Specifications.
2. The work authorized by this permit shall be performed under the supervision and to the satisfaction of the Town Superintendent of Highways.
3. The Town Superintendent of Highways shall be given one week's notice by the applicant of the date when it intends to begin the work authorized by this permit, together with prompt notice of completion of said work.
4. The applicant hereby indemnifies and agrees to hold the Town of Chatham harmless from any damages of any kind or nature which may arise during the progress of the work authorized by this permit.
5. The applicant certifies to the Town of Chatham that all persons engaged or performing the work authorized hereunder are duly covered by workmen's compensation insurance and that the Town of Chatham shall be held harmless on account thereof.
6. Traffic shall be maintained by the applicant on the Town Highway while the work authorized herein is in progress and until it's final completion.
7. Any required culverts will be of minimum fifteen- (15) inch unless otherwise permitted by the Town Highway Superintendent.
8. The Town Superintendent of Highways reserves the right at any time to revoke, modify or annul this permit if the applicant fails to comply with the terms and conditions set forth herein.
9. The applicant will submit securities in the amount specified by the Highway Department to guarantee the restoration of the site to its original condition. Costs incurred by the Highway Department for corrective measures to the Town highway that may be needed due to conditions related to incomplete or unacceptable permit work shall be borne by the applicant undertaking the activity.
10. Landowners are responsible for contacting Underground Facilities Protective Organization at 800-962-7962 before any digging. If recommendations are not followed, The Town of Chatham is not responsible for any damages incurred.

ENTRANCE WORK PERMIT

A. Permits

1. The owner of the parcel, logger, contractor or the developer shall obtain all necessary permits and construct all driveway entrances to the satisfaction of the governing agency.
2. No work shall take place along a Town Highway until a permit has been obtained from the Town Highway Department or Governing Agency.

B. Design

1. The entrance, curbing, gutter, drainage ditch and roadway interference shall be designed:
 - a. Not to channel drainage water from driveway onto or across the roadway.
 - b. Not to channel drainage water from roadway onto driveway.
 - c. Not to interfere with drainage flow along curbing gutter or drainage ditch.

C. Construction

1. For entrances constructed in wet areas, all unsuitable material shall be excavated and replaced with suitable material. Curtain drains should be installed which discharge into the roadway storm drain system.
2. Temporary entrances associated with construction, logging, or other similar use shall be provided with an anti-tracking construction entrance consisting of 12" thickness of compacted 1 ½" stone.
